

Fees and Rates

The following tables detail the standard fees and rental rates for Swift Hall.

*Cleaning Fee is assessed for every rental and includes clean-up and disposal of garbage at the end of the event and cleaning the court. For wedding receptions, fundraisers, and community events, the fee is \$100.00 for laying down the court covering (higher foot traffic in non-athletic shoes).

**If the renter chooses to use the concession area and will be storing items in the area overnight an inventory of items must be taken by the renter before storage, reviewed, and signed off on by both the renter and the maintenance personnel.

Often Swift Hall is rented for long-term rentals for basketball and other sporting tournaments. In this instance, the Parish will offer a discount rate for any consecutive rental of a week or more. The rate, in this case, is \$40.00 /hour for usage between 1-3weeks and \$35.00/hr for usage 4weeks and over. If the tournament charges at the door and sells items on the compound, the rental rate will be \$75 per hour.

Hall usage by not-for-profit organizations receives a 25% discount across the board. In addition, if they use the hall to generate income, they get 25% off the paid rate charge to commercial rentals.

Swift Hall usage by Community and youth programs receives a 50% discount. Note: If the renter uses Swift Hall to generate income, the application of 50% against the paid rate charge for commercial rentals is applicable.

Only the Pastor has the authority to waive or adjust fees as he sees fit (ex., worthy causes, the renter cannot afford fees, etc.). The parish conducts a bi-annual fee review to ensure that the prices charged are sufficient to cover the operating, maintenance, and development needs of Swift Hall.

Advertising space rentals are open to both private and corporate entities. Payments for rentals beyond one month can be made either in full or invoiced monthly. All renters are required to sign an advertising contract.
